## Fire Department Open House - October 8th, 2023



### **Clear Storm Drains**


Storm drains fulfill a great purpose, but can harm water quality when they are contaminated with leaves and debris. Too many leaves or debris around/entering the storm drain causes excess nutrients, sediments, pollutants to enter the river. You can help alleviate this problem by sweeping leaves & debris away from storm drains, inspect storm drains periodically and notify the City if you see an obstruction causing the area to flood.




### **Master Planning Efforts**

The Dayton City Council has initiated a new master planning effort for the area surrounding the planned Dayton Parkway extension to Zanzibar Lane (from 117th Avenue to 125th Avenue). The master planning effort include a visioning session with the Planning Commission, discussions about land use, design standards, climate change strategies and infrastructure with landowners and developers.

A public open house to receive feedback is tentatively scheduled to be hosted in November with a community workshop meeting planned for January 2024. # **Solicitors Need a License**

The City of Dayton has received multiple calls from residents with concerns about solicitors, wanting to know if they are required to have a license. The answer is YES. If someone comes to your door soliciting, please ask them to see their solicitors license. This will be a half sheet of laminated paper that has the dates they are able to go door to door along with a picture. Licenses are non-transferable and only good for a set duration of time. Licenses are also specific to Dayton so you will also want to make sure it is a Dayton license. Please call the police if you have someone come to your door without a license or one from a different City. Residents also have the ability to put their address on a no solicitation list if you would like to be put on the no solicitation list, please email City Clerk Amy Benting at abenting@cityofdaytonmn.com with your address and no solicitors in the subject line. Staff will be working on expanding information on the City website to share both companies and individuals that have active licenses.

# **Hydrant Flushing**



The semi-annual water main flushing program occurs every fall and spring. Hydrant flushing will occur the second week in October. Flushing fire hydrants and water mains is part of routine maintenance necessary to maintain the water system and remove sediment from the lines. The

process of flushing the water system may result in low water pressure, cloudy or discolored water during the days the system is being flushed. The discolored water is not dangerous to your health. Please be aware of the water quality while doing laundry or other tasks that require rust free water.

Please watch for signs placed in your neighborhood when flushing will begin. Please visit our website for resident tips on hydrant flushing under Public Works Department under the Sewer & Water tab.
