Damage to Mailboxes:

Plow drivers try their best to get as close to the mailboxes as possible. If it is determined that the damage is caused by the impact of the snow from snow removal equipment, a reimbursement up to \$100 will be provided to the homeowner. If the damage is determined to be from direct contact with snow removal equipment, the full cost for replacement will be provided to the homeowner. Damage caused by Contractor or County snow plowing equipment does not qualify for reimbursement or replacement. Please report the damage by Contacting Public Works at (763) 427-3224 or kmontgomery@cityofdaytonmn.com. Please provide receipt to kmontgomery@cityofdaytonmn.com or by mailing receipts to 12260 South Diamond Lake Rd and reference your address.

Mailbox Installation:

A mailbox should be installed so its bottom edge is 41" to 45" above street level with the post back from the curb or front of the box. That amount of clearance is needed to keep the plow's wing from hitting the box.

Proper Placement of Carts in Winter

Place carts in cleared driveway with accessible cart spacing




DO NOT:

- X Place carts on top of snow banks
- X Place carts in street
- X Place carts too far back in driveway



Lawn Restoration:

Snow plowing & ice control operations can cause property damage even under the best circumstances. The intent of the right-of-way is snow storage, space for utilities and sidewalks. Where turf has been damaged by City snow plowing, the City will seed the damaged area in the spring. A smart way to shovel your drive

How to reduce the possibility of getting a huge pile of snow in your driveway opening when snowplows clear your street:

Please note: When cleaning driveways please make sure that the snow from the driveway is pushed up behind the curb and not piled in the street. If it is piled in the street the plow will push the snow back into the driveway. Following the diagram will limit the impact and avoid a pile of snow at the driveway entrance.


Keep snow and ice 5 feet away from fire hydrants.

In case of fire, firefighters need to be able to get to the hydrants quickly to protect people and property.

This is intended to be an open house to receive feedback from the landowners, but all residents are invited and encouraged to attend. All written & verbal input will be taken at this open house.

Snowmobiling in Dayton

The City of Dayton has added many new housing developments over the last few years. Although this has brought many changes, one thing that remains is the ability to ride snowmobiles within the City. It is important that those who choose to ride snowmobiles and other recreational vehicles adhere to the rules set forth in both City Ordinance and MN State Statutes. The Police Department receives complaints each year about riders cutting through yards, farmland and riding on walking trails. We ask that riders be respectful and make sure they are riding only in the areas allowed by ordinance and statute. If residents witness riders violating these rules, they should call 911 or the main dispatch number (952) 258-5321 immediately as riders could leave the area quickly.
