## **Temporary Signs Prohibited in ROW**




On December 21, 2023, the City of Dayton's prohibited sign ordinance was amended and went into effect. Signs are prohibited from being placed within the road right-of-way (ROW) The ROW varies depending on the road, but is generally 15' behind the curb on residential streets, and 15'-30' behind the pavement on county roads.

Prohibited signs included the following:

- signs painted, attached or in any other manner affixed to trees or similar natural surfaced, or attached to utility poles, bridges, towers, or similar public structures.
- Obsolete and off premises signs residential districts (except those established prior to January 8, 2008) No signs shall be permitted which advertises a business and is not being presently conducted on the premises on sign location.

## **Spring Hydrant Flushing**



The semi-annual water main flushing program occurs every fall and spring. We will begin flushing hydrants the second week of April. Flushing hydrants and water mains is part of routine maintenance necessary to maintain the water system and remove sediment from lines. The process of flushing the water system may result in low water pressure,

cloudy or discolored water. Please refrain from doing laundry while flushing. The discolored water is not dangerous to your health. Please watch for signs in your neighborhood when flushing will occur.



• Utility bills are sent out bi-monthly. Bills are sent out on the odd months around the 10th and due in the even months

The City of Dayton uses **Invoice Cloud** for electronic billing and payment service. Invoice Cloud is a simple online system that provides more convenient options to view and pay your bill, including the ability to make automatic payments, pay by text, and pay by phone.
